Be Safe, Take A Cab!



SANTA CRUZ >> Empire Grade Road was closed for about nine hours Monday night and Tuesday morning after a driver flipped a pool maintenance truck and was arrested on suspicion of drunken driving.

About 10:20 p.m. Monday, 33-year-old Cory Stevens of Felton was driving a 2001 Ford F-250 south on Empire Grade south of Cave Gulch, said California Highway Patrol officer Brad Sadek.

Stevens lost control of the Ford and struck an AT&T utility pole, causing about 48 gallons of chlorine and eight gallons of muriatic acid from the Ford to spill on the road, Sadek said. Stevens was not injured in the crash, and no other vehicles were involved.

Officers arrested Stevens on suspicion of DUI, Sadek said.

Authorities closed the road so Santa Cruz County workers could clean up the spill. Cal Fire, County Road Maintenance and County Environmental Health Services workers also responded.

Empire Grade was reopened about 7:35 a.m. Tuesday, authorities said.

2015 Minimum Advertised Pricing Policy

Minimum Advertised Price Policy – Pentair Water Pool and Spa, Inc. ("Pentair") has established a Minimum Advertising Price ("MAP") policy for Eligible Products effective Oct 1, 2014. The MAP policy is applicable to any and all Eligible Participants purchasing Eligible Products listed below and participation in Pentair's Partner Incentive Programs. In addition, Pentair's MAP policy establishes specific guidelines under which Pentair may, in its sole discretion, choose to terminate an Eligible Participant in Pentair's Partner Incentive Program ("Program"). Each Eligible Participant will continue to set its own price at which they sell Pentair products. Any Eligible Participant in violation of the MAP policy may be removed from the Program and may lose all accumulated benefits.

Taking A Long Look At The Options

The economic recovery is one reason for the pool boom, which mirrors rebounding home prices and construction. Pools have an obvious attraction at a time of record-setting temperatures.

"People want pools," said Cecil Fraser, owner of Swan Pools in Lake Forest, who doubled his projected sales total in March, his best month since the recession. "Pools certainly are part of the culture here."

POOL VS. LAWN

The pool industry says pools save water compared to lawns and conventional landscaping. When covered to curtail evaporation, a pool's water use is as miserly as drought-tolerant landscaping, it insists.

Local water agency officials say that's true -- but only after a couple of years.

With the state imposing conservation measures, some have called pool use into question. Bans on filling or refilling pools are cropping up in a handful of cities and water utilities throughout the state, including Orange County:

• The South Coast Water District, which serves 40,000 residents in Dana Point, South Laguna Beach and parts of San Clemente and San Juan Capistrano, voted Tuesday to ban the filling or refilling of residential pools or spas. Violators can face fines of up to \$500, said district General Manager Andrew Brunhart.

• The Santa Margarita Water District, serving 165,000 customers in Rancho Santa Margarita, Coto de Caza, Ladera Ranch and parts of Mission Viejo and San Clemente, imposed new restrictions on filling pools and spas in August when it raised its water conservation level to "Stage 2."

That district lifted its ban in September by amending a water conservation ordinance after pool industry officials objected that pools use less water than lawns.

Up north, the Santa Cruz city council will consider next Tuesday whether to re-impose mandatory water rationing, including a prohibition on filling pools and hot tubs.

"We are in an exceptional drought in California. Every drop counts," said Brunhart, South Coast's general manager. "It's incumbent upon every Californian to do everything we can to save every drop of water."

THOUSANDS OF GALLONS

The argument against pools is simple: They require lots of water. It takes at least 15,000 gallons to fill the average pool, and even when covered, pools need to be topped off periodically to replace evaporated water.

The Santa Margarita Water District calculates that a new 500 square-foot pool with a 500 square-foot deck uses 34,275 gallons in the first year, including 18,700 gallons to fill the pool.

By comparison, a 1,000-square-foot lawn consumes 22,000 gallons a year. District officials say that while backyard pools can save water over time, they're net water users in the first year or two.

"Overall, pools gain a water-saving edge after about 2.5 years," the water district asserted. And a pool uses anywhere from 2 1/2 to four times as much water as drought-tolerant landscaping during the "fill year," depending on whether it has a cover or not.

MILLIONS AT STAKE

After five years, an uncovered pool uses twice as much water as drought-tolerant plants; with a cover, the usage is roughly the same.

Like many aspects of the drought, the pool fight features an industry with a lot at stake.

John Norwood, president of the California Pool and Spa Association, estimated that swimming pools generate about \$560 million a year and support just over 8,000 jobs, including pool installers, equipment and chemical suppliers, and pool cleaning services. His organization projects that Californians will build 12,650 new pools this year, requiring about 227 million gallons to fill them.

Industry officials point out that pools are accompanied by cement decks, and claim that once filled, the pool itself uses a fraction of the water of the typical backyard lawn.

"You're going to save lots of water with a pool," said Norwood. "With a cover, you're going to save even more."

Yorba Linda resident Don Gabel said when it came time to fill a new kidney-shaped pool and spa in his refurbished backyard, it gave him pause.

But ultimately, the need to have a backyard that will be a social hub for his children and their friends during their high school years outweighed those concerns. The new yard also includes a fire pit and barbecue.

"I have a plan to keep my kids around. It's going to be worth it," said Gabel, a building contractor. "To be honest with you, I didn't give (water use) a whole lot of thought."

WHAT ABOUT SPRINKLERS?

Meanwhile, he said, nobody's doing anything about a neighbor with broken sprinklers who generates a "creek running down the gutter every day." He complained, but his neighbor hasn't stopped her daily watering, he said.

"I thought if the water district isn't going to pay attention to that, if no one's concerned about it other than me, I didn't have too much concern about filling my pool," he said. Newport Beach resident David Clarke believes his new pool will be a net water saver.

The pool is about a third the size of an older pool that he believes was leaking. Clarke and his family tore the old pool out while rebuilding their home of 10 years. About two-thirds of their landscaping also has been removed, further curtailing water consumption.

But Clarke objects to local cities and utilities imposing bans on filling pools until they clean up their own act. He sees medians being watered in the middle of the day in Costa Mesa and criticized local governments for capturing just a fraction of rainwater runoff.

"It's not fair to regulate people's use in their own backyards," Clarke said.

Pool installers like Ken Tipton, owner of ABC Pools in Los Alamitos, note that customers sometimes ask if they'll have problems filling their pools.

But while people with lawns can let them go brown, owners of older pools have few options other than to keep using them.

"If we drain the pool, it's going to blister and crack all the plaster, and it's going to cost them \$5,000 to \$6,000 to drain it," Tipton said.

COVERS ARE REQUIRED

Huntington Beach requires new pool owners to install covers to reduce water evaporation. The city won't sign off on a new pool permit until it has some type of a cover. Fountain Valley requires that new or remodeled pools either have a cover or solar heating to reduce energy consumption. The Santa Margarita Water District estimated that a pool cover could cut a 500-square-foot pool's evaporation from 15,575 gallons a year to 4,700 gallons annually. While covers sell for as little as a few hundred dollars, Jeffrey Whitten is splurging on an automatic cover when he installs his new pool at his Corona del Mar home next fall. "It helps with the evaporation and keeps the pool warm,"

Whitten said. The new pool is part of a \$100,000 re-landscaping that in-

cluded removing an old pool and ripping out the lawn. Instead, the Whittens are using concrete, artificial turf, drip irrigation and drought-tolerant plants. The new rectangular pool and spa also will be more efficient and economical than the old one, which dated back to the 1960s.

"The whole plan of the new landscape was we're using too much water," he said. "We had grass in the front and the rear yard. That's where all the water was going. I estimate that it's going to be 60 percent to 70 percent less (water) than before."

SJWC's water conservation rules to achieve the 20% conservation target is now in effect through June 30, 2015. The rules mostly apply to outdoor use that typically accounts for 50% of a typical customer's usage. No customer shall use utility-supplied water for non-essential or unauthorized uses as defined below:

• Use of water through any connection when the utility has notified the customer in writing to repair a broken or defective plumbing, sprinkler, watering or irrigation system and the customer has failed to make such repairs within 5 days after receipt of such notice.

• Use of water which results in flooding or run-off in gutters, waterways, patios, driveway, or streets.

• Use of water for washing aircraft, cars, buses, boats, trailers or other vehicles without a positive shut-off nozzle on the outlet end of the hose. Exceptions include washing vehicles at commercial or fleet vehicle washing facilities operated at fixed locations where equipment using water is properly maintained to avoid wasteful use.

• Use of water through a hose for washing buildings, structures, walkways, patios, parking lots, tennis courts, or other hard-surfaced areas in a manner which results in excessive run-off or waste.

* Use of drinking water for washing driveways and sidewalks.

• Use of water for watering streets with trucks, except for initial wash-down for construction purposes (if street sweeping is not feasible), or to protect the health and safety of the public.

• Use of water for construction purposes, such as consolidation of backfill, dust control, or other uses unless no other source of water or other method can be used.

• Use of water for more than minimal landscaping in connection with any new construction.

• Use of water for outside plants, lawn, landscape, and turf areas more often than every other day, with even numbered addresses watering on even numbered days of the month and odd numbered addresses watering on the odd numbered days of the month, except that this provision shall not apply to commercial nurseries, golf courses and other waterdependent industries.

• Use of water for watering outside plants and turf areas using a hand-held hose without a positive shut-off valve.

• Use of water for decorative fountains or the filling or topping off of decorative lakes or ponds. Exceptions are made for those decorative fountains, lakes, or ponds which utilize recycled (*see footnote) water.

• Use of water for the filling or refilling of swimming pools (**see footnote).

• Service of water by any restaurant except upon the request of the patron.

Due to limited availability of surface water supplies, SJWC anticipates delivering more groundwater throughout its service area in the coming months. Groundwater may exhibit a more pronounced chlorine taste or odor and this supply source is also typically "harder" than the supply normally provided. Groundwater remains safe and appropriate for all potable uses.

The Backyard Swimming Pool And The Drought

Once a pillar of suburban comfort, the backyard swimming pool is now the prey of many California communities trying to save water.

Drought policies passed by cities and utilities across the Bay Area and beyond are increasingly targeting the liquid luxury by limiting how often pools can be filled and by how much — and sometimes barring fill-ups entirely.

Now, as a fourth dry year looms, some pool owners are finding it easier to throw in the towel rather than play by the rules, and they're simply doing away with the fixture.

"We're going to have restrictions and rationing come June, and it'll be less water I use," said San Jose resident Eddie Manguray, who paid about \$8,000 this month to have his pool removed. "It was starting to have leaks anyway," he added. "I decided that rather than spend the money remodeling, just get rid of it."

While representatives of California's \$5 billion pool industry say they haven't felt much of a hit from efforts to edge out the amenity, they're not taking chances. Lobbyists are visiting communities across the state to make the case that pools can be water-friendly features and don't need to be sanctioned.

'You have to draw a line'

They say the notion that a pool is any worse than a yard is a myth. But the message has only gotten so far.

"It's much more reasonable to be removing a pool than putting one in at this time," said Chris Burd, owner of Dig & Demo in Sunol, who said the dry days have been good for his 10-person demolition company, which pulled out 150 pools in the past year, most in the South Bay.

"We're a small company, too," he said. "We could do more if we were bigger."

In San Jose, where warm weather and larger lots lend themselves to a refreshing dip, the number of permits given for pool removals this year is nearly four times the number granted for installations, according to city records. This is unusually high.

Only once since 2000 have pool demolitions outpaced new pools — and that was in 2010, on the heels of the housing crisis. Even then, removals barely edged out installations.

While city officials can't link the numbers to the drought, they say it likely played a role.

The South Bay's largest water provider, the San Jose Water Company, which serves most of San Jose and the neighboring Silicon Valley suburbs, has prohibited customers from filling new swimming pools as well as draining and refilling existing ones, with some exceptions. Violators face fines of up to \$500 a day.

The city of San Jose has passed an additional ordinance limiting residents from topping off their pools with more than 1 foot of water. Similar restrictions extend from Santa Cruz to Novato to Dublin

"The bottom line is we thought it was a waste of our drinking supply to fill a new pool," said Dan Gallagher, operations manager for the Dublin San Ramon Services District, which banned fill-ups last year when the area's water wholesaler pared back deliveries. "You have to draw a line at a certain point for what's important to a community."

Some water agencies, such as the East Bay Municipal Utility District, are going as far as giving rebates to customers who remove a pool and replace it with something more waterefficient. Removals can run between \$6,000 and \$15,000.

Mandatory cuts a factor

The crackdown on pools is part of a bid by cities and utilities to meet state-ordered water reductions. Starting Monday, communities face mandatory cuts between 4 and 36 percent over their 2013 consumption, with places that have used more water in the past forced to cut the most now.

Representatives of the pool industry, though, say including pools in the conservation push makes little sense.

"We understand that water districts are under increased pressure to find ways to conserve water, but imposing a ban on filling or building pools is not the answer." said John Norwood, president of the trade association. "We wanted to educate water districts about the fact that pools and spas do not waste water and can be as efficient as drought-friendly landscaping."

The organization has launched a campaign. "Let's Pool Together," to not only promote pools as water-wise, but also encourage pool owners to be as efficient as possible during the drought. Officials urge residents to use pool covers as well as turn down the heat to limit evaporation.

Less splashing, too. That means no cannonballs. Water agencies divided

Industry surveys suggest pools continue to be popular. The number of installations appears to have risen in 2014, though some say the size of new pools has gone down considerably. There are an estimated 1.2 million residential pools in the state, according to the California Pool and Spa Association.

Some water agencies have rolled back pool restrictions after hearing what industry representatives have had to say. The Santa Margarita Water District in Orange County, for example, did its own analysis and decided to lift its prohibition on fill-ups.

"You fill the pool once. Grass you water once a day or sometimes three times a week," said Jonathan Volzke of the Southern California district.

Using neighborhood pools

Other communities, however, have remained firm on their pool restrictions. Some say comparing a pool's water use to a lawn's water use is disingenuous. A grassy yard isn't the only substitute, they noted, and a patio or certain vegetation can be a lot more water-efficient.

Santa Clara resident Mary Morse said her family's water use dropped between a guarter and a third after removing the swimming pool in June. She replaced it with artificial turf.

According to the California Pool and Spa Association, an As with others, the drought wasn't the only reason Morse got

The number of articles, stories and press reports on the drought today really tell the story about how big this issue is in California. Good news is that CPSA is being quoted all the time and our message is getting out. Bad news is that our message sometimes is misunderstood, the other real bad news is that some cities admit that pools and spas are non-water wasters, but they are non-essential uses of potable water so that is what they are using to impose water use restrictions. All of this is just the beginning as the state's Model Water Efficient Landscape Ordinance just going into effect may be the biggest threat of all. These landscape regulations only look at the water in a pool, and not the surround decking, which means pools are considered the same as lawns and will be downsized.

How Much Does it Cost to Run A Pool Heater?

Quite often we get the question How much does my pool heater cost to run? Here's some quick information to help you figure out how much it is costing you to heat your pool.

Propane Pool Heaters

You can figure about 1 gallon per hour per 100,000 BTU's to operate a propane pool heater. For a typical 400,000 BTU heater, that's 4 gallons per hour. Currently Propane runs about \$2.50 per gallon, propane prices do fluctuate so keep an eye on this website updating the <u>National Average Cost of Propane</u>. In our example, 1 hour on propane will **cost \$10.00**.

Natural Gas Pool Heaters

You can figure about 1 therm per hour per 100,000 BTU's for Natural Gas. For a typical 400,000 BTU pool heater, that's 4 therms per hour. Currently Natural Gas runs about \$1.00 per therm, natural gas prices do fluctuate so keep an eye on this site showing the <u>Cost of Natural Gas Per State</u>. In our example, 1 hour on Natural Gas will cost \$4.00.

Heat Pumps

You can figure about 5,000 watts or 5 kilowatts per hour per 100,000 BTU's for a heat pump. For a typical 100,000 BTU heat pump, that's 5 kilowatts per hour. The national average for Electricity runs \$.13 cents per kilowatt hour. Electricity costs vary widely throughout the United States so checkout this website updating the <u>Electricity Costs for all 50 States</u>. In our example, 1 hour on a heat pump will cost .60 cents.

Chlorine Is Innocent

Those red eyes you get from swimming aren't caused by chlorine, according to an official with the Centers for Disease Control and Prevention.

"Chlorine binds with all the things it's trying to kill from your bodies, and it forms these chemical irritants. That's what's stinging your eyes. It's the chlorine binding to the urine and sweat." DR. MICHAEL J. BEACH, ASSOCIATE DIREC-TOR OF THE CDC'S HEALTHY WATER PROGRAM

For their annual Healthy Swimming Program, the Centers for Disease Control (CDC) teamed with Water Quality and the Health Council and the National Swimming Pool Foundation to educate Americans about the dangers of pools and how to stay healthy when swimming, Women's Health reports.

Beach went on to say that the cough you can get from an indoor pool is also caused by the chemical reaction. The chlorine isn't what causes the irritation in your lungs; it's pee

There's actually been an increase in disease outbreaks from public swimming pools, according to Beach, thanks in large part to those swimming while they have diarrhea. Those with diarrhea don't even have to defecate in the pool to spread disease, but just have the germs on their body, which is why the CDC encourages swimmers to shower

before getting in the pool.

"We have a new parasitic germ that has emerged that's immune to chlorine," says Beach. "We've got to keep it out of the pool in the first place. We need additional barriers."

The misconception that chlorine just eliminates all germs upon contact is untrue, and it takes time to properly disinfect for each germ. While chlorine kills most bacteria such as E. Coli in less than a minute, it takes at least 16 minutes to kill Hepatitis A, and the Cryptosporidium parasite can last in the swimming pool for over 10 days.


The CDC says the only way to prevent recreational water illnesses is to keep germs out of the pool in the first place and to practice the following steps for healthy swimming:

SPREAD THE WORD

- Stay out of the water if you have diarrhea.
- Shower before you get in the water.
- Do not pee or poop in the water.
- Do not swallow the water.
- Take kids on bathroom breaks.

• Check diapers, and change them in a bathroom or diaperchanging area -- not poolside -- to keep germs away from the pool.

- Reapply sunscreen.
- Drink plenty of fluids.

Pool Industry Cannot Back Down

54 new swimming pools and family backyards were saved last week when the Laguna Beach City Council voted unanimously to overturn the moratorium on issuing new permits for swimming pools, spas and hot tubs as initially passed at the July 14th Council meeting. Also saved were the jobs of numerous contractors and sub-contractors, permit fees and new property taxes that go along with such home improvements!

This was a big deal. CPSA had been working with city staff since the day after the City Council voted without any public notice or industry involvement to impose such a moratorium. Clearly this was, at best for the city, an opportunity to research this topic and make an informed decision. At worst, it was a knee-jerk reaction that we have observed from numerous cities and water districts. However, once the facts are highlighted, bans on new permits for pools, spas and hot tubs and prohibitions on using public water to fill new pools are very hard to justify.

The problem is that getting the facts before policy makers and the public is hard work and expensive, especially given media costs in California and the current environment where drought-shaming seems to be prevalent. That is what makes this success all the sweeter. Over the past 20 months CPSA has been working with state leaders, water districts and cities throughout California as well as the media to share the facts about water use by swimming pools, spas and hot tubs. Compared to turf farmers and almond growers, we have been wildly successful. CPSA has had over 70 newspaper articles posted and have participated in an untold number of radio and television stories relative to various proposed water use restrictions. We have had editorials posted in the Orange County Register, Los Angeles Times and have even been highlighted in National Geographic just to mention a few. In most instances we now have the media on our side which is invaluable.

All of this work paid off again last week in Laguna Beach. CPSA provided the city staff with all of our materials relative to the facts about water use by swimming pools, spas and hot tubs: the economic impact report CPSA had commissioned by PK Data and numerous articles and research that supported our position that pools and spas are not water wasters.

were also tipped off that the City of Fort Bragg has a prohibition on filling swimming pools. As a result, we have begun engaging these policy makers.

Bottom line, this is hard work and it is expensive, which is why we need to keep working to expand the membership and financial support for CPSA. If you are reading this, CPSA is defending your job or business; please help spread the word. Here are some facts:

1. Swimming pools, spas and hot tubs are not water wasters. This fact has been confirmed by the state, numerous water districts and cities.

2. There are no state prohibitions on the use of public water to fill or refill pools or spas. This includes the Governor's Proclamations and State Water Resources Control Board regulations.

3. Approximately 13,000 new pools will be built in California during 2015. The amount of water it will take to fill these new pools is approximately 8/1000 of 1% of just the state's water used for urban purposes.

4. New swimming pools, spas and hot tubs use a tiny fraction of 1% of a city's or water district's annual water use. Generally a rounding error! This fact has caused several cities that enacted bans on filling new pools to reverse their actions and prevented others from taking any action relative to swimming pools and spas.

5. Once built, swimming pools use about the same amount of water through evaporation as the same size area planted in drought resistant landscaping. If the pool is covered when not in use, the pool will use 1/2 of the water that drought resistant landscape uses annually. Covered spas and hot tubs lose less than 5% of water due to evaporation as they are always covered to keep in the heat.

Soda Ash vs. Baking Soda

"You know you're the only one who buys that," the counter person at my local distributor would say as he headed to the warehouse to pull a 50-pound bag of soda ash.

The industry standard has always been to use sodium bicarbonate (baking soda) to raise total alkalinity and sodium carbonate (soda ash) to raise pH — the exception being if both total alkalinity and pH are low. Understanding that it is impossible to raise (or lower) one without effecting the other chemically, there is still a "right tool for the job" analogy that comes into play.

Using sodium bicarbonate will have a more measurable effect on total alkalinity, while only raising the pH of water slightly. Sodium carbonate will actually have a dramatic effect on both pH and total

alkalinity. Using sodium bicarbonate to raise pH is the equivalent of driving a nail into a wall using the handle of a screw driver — it can be done, but a hammer would handle the job more effectively and at much less of a cost.
